emailed.

Question: Received 7/16/25: Part A – complete just 11-15 only?

Answer: This is all that is required. Refer to section L for details on the other section.

Question: Received 7/16/25: Part B - How can I estimate without knowing referral based on

unknown quantity?

Anything that is noted as Unknown does not require a price, that is noted in section B

and there is no place to provide prices for these services. These are services that will be reimbursed at the actual cost, so a cost is not required at this time. Refer to section L for

more details on submission of prices.

Question: Received 7/16/25: Section C - I do not need info/signatures – correct?

Answer: Refer to section L and review the actual form.

Question: Received 7/16/25: Section J - are these attachments to be use for referrals vs. my own

program materials? TX log – in is mental health info needed?

Question: Received 7/16/25: Section K - do I complete as required, is there anything I should know

here.

Question: Received 7/16/25: Several specific questions submitted regarding Section L

subcontractors, CASOMB certificate, Part B, Part C, Part D references and what needs to

be completed.
