The purpose of this letter is to answer questions received, regarding solicitations issued by the Eastern District of California, for Fiscal Year 2021:

Question: Regarding the due date for questions, are there questions in the RFP document?

Answer: Should you have questions regarding the RFP, we request they be submitted by July 1, 2020. To ensure the process is fair to all offerors, all questions will be answered as they are received and posted to our website.

Question: Regarding RFP # 0972-21-12SM, what area is the bid for?

Answer: The catchment area for RFP # 0972-21-12SM is Madera and Merced Counties, which may be found in Section B of the RFP.

Question: Regarding RFP # 0972-21-07SA, did you mean for Project Code 6015 to be on the substance abuse proposal?

Answer: Yes. On the previously awarded solicitation from Fiscal Year 2018, the Project Codes for Integrated Treatment for Co-Occurring Disorders (Project Codes 6015 & 6026) were included on the Mental Health solicitation. However, these project codes are classified under Substance Abuse Treatment and paid from that fund. Therefore, both Project Codes 6015 and 6026 have been included substance abuse RFP for this Solicitation.

Question: Can you please provide the Incumbent and their award amounts for the recently released RFPs?
